MAY 2025: WHAT THE BOARD OF TRUSTEES IS WORKING ON

Posted May 5, 2025

➤ Budget, Budget. We are meeting with Taylor Management to review last years expenses vs the budget. We will create the new budget for 25/26. This will include the new HOA Fee, Operating budget, Preventative Maintenance issues and Reserve Requirements.



- ➤ We are meeting with the Finance Committee to get their input
- ➤ We are planning the presentation to the community at the Open Meeting on June 12th. The Recreation Committee will be providing goodies for a social event at the end of the presentation. The new HOA monthly fee will be announced at that meeting. We are trying to thread the needle between costs and minimal HOA fee increase.
- ➤ We are working with ZD Stucco on the Refresh project. They have completed 22 buildings so far and are doing a great job of making the building leak free and coating the surfaces with bright new paint.
- ➤ We have agreed to install an automated pool water tester and a machine that will add the appropriate amount of chlorine. Our goal is to get the pool open by Memorial Day. There are many steps involved along with certain state and town rules and inspections that we need to comply with. Once we get new signage and the equipment working, we will eliminate the pool monitors and the costs that go with them.
- ➤ We are doing what we can to extend the life of the fences. They are custom made out of cedar and extremely expensive to replace.
- > We passed a resolution requiring mandatory dryer vent cleaning every three years. This is to eliminate the threat of fires. Tara is working on getting a contractor who will perform the work this year

UPDATE NEW EXTERMINATION RESOLUTION

The Extermination Resolution approved by the board moves the cost of exterminating animals inside the unit to the unit owner, effective July 1, 2025. The association has paid the inside extermination costs because of the roofing project. We can no longer afford to continue to do that without a greater HOA fee increase. We will continue to pay outside extermination costs for bees, wasps and other outdoor critters like we have done in the past.

If you need an exterminator we suggest you call Accurate Pest Control (973-398-8798). They have done a lot of work in the development, so they know our rules and regulations and are familiar with our buildings roofs and siding. However, you may use any exterminator you like.

Swimming Pool

Automation

In 2025, Four Seasons at Chester (Four Seasons) will be transitioning its pool operations from a manual system to an automated one. There are several benefits for our community from this transition and they include:

- Cost savings over time due to not having to meet the requirement for a Certified Pool Operator (CPO) on site when the pool is open, in order to perform mandatory testing and to adjust chlorine and other water purification/conditioning chemicals. This process will be handled by the automated system with the oversight (remotely) by the CPO.
- Improvement of pool access and availability. Residents of Four Seasons and their guests will be able to use the pool during operating hours without the need for a monitor being present on site.

Note that this transition is not without certain logistical challenges. As with any significant system or operational change, time will be required for installation, testing and adjustment before pool operation is fully automated.

The installation of the required equipment is scheduled to take place during June, due to our contractor's availability. During the time that the steps necessary to fully automate the pool are pending, a CPO monitor will need to be at the pool site for it to be open for use.

These logistical issues have been discussed at length by the Board of Trustees, the Pool Committee and with our CPO pool contractor.

Please be assured that every effort is being made to efficiently transition pool operation to full automation and to not disrupt pool access and availability once the season opens.

FOUR SEASONS AT CHESTER POOL RULES 2025

Resident means any individual person whose address for taxation, post, utilities, or other purposes lies within Four Seasons at Chester.

Guest means any individual person who is not a resident of Four Seasons at Chester, using the pool in the company of a Resident.

SWIMMING IS AT ONE'S OWN RISK; THERE ARE NO LIFEGUARDS OR MONITORS.

- 1. All residents must enter the pool area using their Clubhouse entry fob.
- 2. Guest(s) using the pool must be accompanied by a resident, who must stay with, and be responsible for them.
- 3. All persons under the age of 18 must be accompanied by an adult resident.
- 4. Swimmers should not swim by themselves, especially if they have any physical or medical condition which might affect their swimming ability. Swimming with a friend is strongly encouraged.
- 5. There is no swimming if there is lightning or thunder occurring, or in the imminent forecast.
- 6. The pool will be open 10:00 a.m. to 7:00 p.m., weekends only, from Memorial Day, 2025 until June 21, 2025, and then will be open 10:00 a.m. to 7:00 p.m. daily from June 22, 2025, until Labor Day, 2025.
- 7. Resident adult swim hours (no one under 18 years of age) are daily 10:00 a.m. to Noon when the pool is open.
- 8. If a swimmer wears diapers, the diapers must be those designed especially for swimming.
- 9. Pool users are not allowed to use any Clubhouse facilities other than the basement restrooms.
- 10. Pets, except service animals, are not allowed in the pool area. Service animals are not allowed in the pool.
- 11. Neither smoking nor vaping is allowed in the pool or spa areas.
- 12. No glass containers are allowed in the pool area.
- 13. No alcohol or cannabis products are allowed in the pool area. Alcohol may be consumed only at an event sanctioned by the Board or its authorized committees.

Those using the pool should be considerate of others, such as avoiding horseplay, running, splashing, or jumping into the pool.

Users of the pool must clean up after themselves, and rearrange pool furniture to how it was found. This is your pool, everyone who uses it is responsible for maintaining it and keeping it clean.

Any violations of these rules may result in a Resident and/or their Guests losing their privilege to use the pool.
